SUBSTANTIAL AMENDMENT CDBG-CV

In accordance with federal Community Development Block Grant (CDBG) program regulations, the County is permitted to make substantial amendments to its Annual Action Plan and Budget in accordance with the County's Citizen Participation Plan which was revised in June 2020 in accordance with the CARES Act. Montgomery County has determined that it is necessary to amend the approved CDBG program budget for the previously approved program year 2019 Annual Action Plan. This is considered a substantial amendment in accordance with the County's Citizen Participation Plan as the following applies: a) Adding or canceling an activity.

The Substantial Amendment to the PY 2019 Annual Action Plan proposes to cancel the following amounts from the CDBG-CV3 projects listed below:

This document will be available to the public for a period of thirty (30) days until February 29, 2024, after which time the Substantial Amendment will be considered by the County Commissioners for final action.
